* Defence Purposes Designation - (Waiouru Military Training Area)

The military camp and training ground at Waiouru comprises approximately 62000 hectares of land (30km by 25km) alongside State Highway No 1 to the north and south of Waiouru township. It is bounded in the north by the Kaimanawa State Forest Park, in the east by the Rangitikei River, the Hautapu Stream in the south, and extends to the lower slopes of Mt Ruapehu in the west, which includes part of the Rangipo Desert ([Te Onetapu](#)).

The Waiouru Military Training Area is the major military training area in the North Island. The area subject to the designation is primarily used as a camp and field firing/manoeuvre area.

Reasons for the Designation

Defence Purposes

The Waiouru Military Training Area is administered by the New Zealand Defence Force (NZDF) and currently occupied by the New Zealand Army, Royal New Zealand Navy and on occasions units of the Royal New Zealand Airforce. The military camp and training area is a Defence Work and is designated for Defence Purposes to enable the NZDF to train and prepare for any or every purpose required of the Defence Force by section 5 of the Defence Act 1990, as follows:

- (a) The defence of New Zealand, and of any area for the defence of which New Zealand is responsible under any act.
- (b) The protection of the interests of New Zealand, whether in New Zealand or elsewhere.
- (c) The contribution of forces under collective security treaties, agreements or arrangements.
- (d) The contribution of forces to, or for any purposes of, the United Nations, or in association with other organisations or states in accordance with the principles of the charter of the United Nations.
- (e) The provision of assistance to the civil power either in New Zealand or elsewhere in times of emergency.
- (f) The provision of any public service

The Nature of the Public Work

The Defence Act 1990 provides for the raising and maintenance of the Armed Forces. The Public Works Act defines a defence work as:

- (a) Any naval establishment, army camp or air force base.



- (b) Any arsenal and any other structure or place used for the purposes of constructing, repairing, making or storing munitions or equipment for or belonging to the Armed Forces.
- (c) Any other fortification, camping ground, training ground, parade ground, rifle, artillery, tank, weapon or bomb range, or other work however designated which is constructed or intended to be used for the purpose of defence, and all roads or other works which may be requisite for approach to or otherwise necessary or convenient for the purposes of any such defence work

The Waiouru Military Training Area provides an environment that is essential in enabling military operational capability to be maintained in order to meet the purposes of the Defence Act. Activities undertaken at this site include the development, maintenance, and improvement of appropriate Army, Naval and Air Force levels of operational preparedness. The military camp provides facilities and infrastructure for training purposes and to support units in the field. The training area provides a natural environment that enables operational and tactical training to be practised in the field together with the live firing of military weaponry.
