- A written reference from your employer at the licensed premises at which you are currently working. This should confirm your employment on licensed premises, how long you have worked there and relevant duties.
- A written character reference from someone able to verify your suitability to hold a Manager's Certificate (reference from your employer at the licensed premises at which you are currently working, family members or relatives are NOT acceptable).
- Copy of photo ID (NZ Drivers Licence or Valid Passport)
- Copy of Work Permit/Visa (if applicable)
- A copy of your Licence Controller Qualification (LCQ).
- If your LCQ was issued in 2013 or earlier under the Sale of Liquor Act 1989, a copy of your LCQ Bridging Test completion certificate. *For more information please see [www.serviceiqskillsonline.org.nz/lcq-bridging-test](http://www.serviceiqskillsonline.org.nz/lcq-bridging-test).*  
Other evidence to support your application regarding character, suitability and training (*not mandatory*), eg, a CV (if you have had experience working in or controlling licensed premises) and/or any relevant training certificates.

**Each applicant is required to attend an interview with a Licensing Inspector, which will include a test on the Sale and Supply of Alcohol Act. You will be contacted after your application has been received to arrange an appointment for your interview.**
