2.1 Significance

#### Background | Tuhinga

- 3.1 The Community Boards Executive Committee (CBEC) represents all the community boards in New Zealand.
- 3.2 CBEC is an advisory committee to Local Government New Zealand's (LGNZ) National Council. It advocates for community boards and promotes best practice.
- 3.3 CBEC has one member from each of LGNZ's six geographical zones. Ruapehu District Council is in Zone 3.
- 3.4 Elections for CBEC representatives are held after the local government elections each triennium. Each community board has one vote for its zone representative.

3.5 CBEC meets three times a year in Wellington. As well as these meetings, each zone representative run regular zone forums to update community board members and discuss topical issues

#### Discussion | He Korerorero

- 4.1 LGNZ has received two nominations for Zone 3's representative and requires the Community Board to cast its vote by 1 March 2023.
- 4.2 The official voting form is **attached** to this report and includes the biographies of the two candidates.
- 4.3 The candidates are Marcus Buddo, Rural Community Board, Hastings, and Sarah Lucas, Inglewood Community Board.

# **CBEC CANDIDATE BIOS – ZONE 3**

## **Marcus Buddo**

Marcus Buddo believes that Community Boards have a very important role to play in Local Government, one that will only get more critical over time. The intimate ties to communities that Community Board members have is an incredible asset to making considered and appropriate decisions around the Board and Council table.

Elected to the Hastings Rural Community Board in 2019 at age 24, Marcus has since successfully run for the Hastings District Council. He has degrees in Politics, Economics and Health Science, and has managed farming and forestry properties for the last five years.

Marcus' term on the Community Board was invaluable experience. The relationships he formed with Councillors, Board Members and Council Staff have stood him in good stead, while the knowledge of Local Government processes and language has enabled him to hit the ground running in his new role. Community Boards are a brilliant training place for Local Government politicians, and add vital insight and advocacy for communities that may not otherwise have their needs met.

Marcus would like to see Community Boards across the country better recognised and understood, both by the general public and their Councils. We need more competent, respected boards, which have the capability to take on more responsibilities. ### Sarah Lucas

I have been keeping up to date into the current review of the future of local government, and see many areas that improvements could be made to bring local democratic processes closer to the people they represent.

Community Boards are unique. They provide real grassroots representation and have an important role to play in the decisions that get made in governance.
