The Taumarunui–Ōhura Community Board received addresses as follows:

#### 6.1 Joke Brady

Joke Brady addressed the Community Board regarding Public bike racks in Taumarunui. Ms. Brady requested Council investigate installing additional bike racks around the main street of Taumarunui. As bikes can be expensive items, it was felt cyclists would prefer to be able to leave their bikes closer to where they are stopping for security.

Ms. Brady noted any new bike racks would need to be able to accommodate the wider tyres that many bikes have now. There are different style offered: a "lollipop" stand which can accommodate two bikes parallel to the road, or a ground fixed rack which can accommodate four to five bikes but take up more room. One option may be to convert a car park, or other indented area on the side of the road, so that the bikes are not obstructing the footpath.

It was noted that throughout February and March approximately 3000 cyclists were anticipated to be coming through Taumarunui for various cycling events. Council's Executive Manager Infrastructure advised that any new cycle racks would be included in the Walking and Cycling strategy and that there may be outside funding/subsidy available to the project.

# L1 Temporary Road Closure Application: Taumarunui Anzac Dawn Service and Civic Service, 25 April 2023

Members agreed to consider the Late Item report that sought approval of the temporary road closure application for the Taumarunui Anzac Dawn and Civic Services, planned for 25 April 2023. The request for the road closure was submitted by Ruapehu District Council's Chief Executive and seeks road closures on Anzac morning, Tuesday 25 April 2023 from 5:30AM to 1PM, along Morero Terrace, Miriama Street and Hikaia Street, Taumarunui to enable the Dawn and Civic Anzac Services to go ahead without traffic impediment. Council's Chief Executive spoke to the report and answered Members' questions.

#### Key Items Discussed:

- **8.1** C2: Taumarunui Domain: Fanshawe Garden needs a working bee to carry out weeding. The new accessway needs to be brought up to standard then maintained. Cr Neeson undertook to contact Tim Leahy and a gardener's group to organize the work.
- **8.2** C3: Taumarunui Walkways Operational Budget. Cr Neeson stated how important the various walkways are and requested the Xyst report be recirculated to the Community Board members.
