8 Temporary Road Closure Application: Raetihi Gutbuster, 22 April 2023

Members were presented with a report seeking approval of the temporary road closure application for the Raetihi Gutbuster Event, planned for 22 April, 2023. Council's Executive Manager Infrastructure spoke to the report and answered Member's technical questions. Cathy Rogers of Raetihi Promotions Charitable Trust, the organisers of the event, was in attendance to answer event specific questions.

The event base will be at Waimarino Museum, incorporating the start and finish lines and space for food and produce stalls. Following feedback from previous event attendees, the 2023 Raetihi Gutbuster now comprises four events; a 50km and 25km bike event, a new half-marathon, and a new family fun-run/walk designed to encourage more local participation. The community event is traditionally a fund raiser for Raetihi Promotions Charitable Trust, as well as giving back to those within the community through donations to volunteer groups that support the event.

9 Capital Works and Members Request for Information

Members were provided with an update on planned Capital Works in the Waimarino-Waiouru Ward in the 2022/23 Financial Year. Relevant officers spoke to this report and answered Members' questions.

Key Items Discussed:

- **9.1** R2: Ruapehu Road Rail Overbridge replacement. Work has commenced on the bridge. Officers advised the timber being taken up was being assessed for condition and suitability to be repurposed as part of the Ohakune Wayfinding and Signage projects.
- **9.2** R6: Bus Parking Mangawhero Terrace Extension and Shannon Street. Officers undertook to share the design with Members by email.
- **9.3** C5: Accessible Walkways: The Ameku track is near completion.
- **9.4** C7: Raetihi Cemetery Extension: Officers advised a solution to accommodate the additional 70 plots had been found without the need to purchase additional land.

- **9.5** C8: Waimarino Rest Home: Officers advised the handover had not yet been completed, and plans for upgrades would be initiated as soon as the transaction was finalised.
- **9.6** C10: Waimarino Toy Library: Officers advised the building was in the final stages of renovation.
- **9.7** D1: Raetihi Community Hub: The expression of interest document for the design phase has been uploaded to the Government Electronic Tender Service (GETS) where it will be available for submission for one month.
- **9.8** D2: Raetihi Town Revitalisation: Officers undertook to arrange a meeting with the interim steering group, including Member Reid as the Community Board's appointed member.
- **9.9** D4: Raetihi Swimming Pool: the leak has been identified and work will commence to fix this during the off season. Members requested Member Reid is consulted as part of the review process.
- **9.10** D5: Waiouru Playground: Analysis of consultation feedback is being conducted and a report will be tables at the May meeting of the Community Board.
- **9.11** O1: Security Cameras (Ohakune): Council is waiting on the electrician to connect up the power. He has said that he will be over week commencing 3 April to compete this work ready for the CCTV contractor to install the cameras.

6.1 Nicholas Hill

Nicholas Hill presented a brief proposal to open a food truck along SH4 in Raetihi to provide an evening food service when the "bricks and mortar" food and beverage businesses were closed. Waka Kotahi New Zealand Transport Agency does not currently permit this activity on State Highways, however, it might consider Mr. Hill's application if he could demonstrate the support of the local authority. Mr. Hill addressed the board to seek its initial support before progressing the proposal. The Community Board recommended Mr. Hill canvas the local food and beverage businesses before presenting a formal report to the Community Board for endorsement to Waka Kotahi.
