- 4 The application must be filed a minimum of 15 working days before possession or the commencement of selling alcohol.
- 5 A person holding a Manager's Certificate must be employed on the premises before a Temporary Authority can be issued.
- 6 A Temporary Authority is a temporary licence allowing the holder to operate off the existing base licence for three months while they apply and are issued with a new (On or Off) licence.
- 7 Should that new licence not be issued in the three month period (for good reason) then a further Temporary Authority may be considered, provided the substantive licence application has at least been filed with the District Licensing Committee.
